1. What is the aim of the policy, strategy, project, programme or scheme?

The aim of the programme is to reach out to new audiences and persuade more people to get involved in the arts. The programme is specifically aimed at those audiences who feel particularly disengaged from the arts or face barriers to getting involved.

The programme as a whole aims to support initiatives that will attract people from a range of backgrounds, however in the first instance we are targeting children, young people and families.

2. Who is affected by the policy or who is intended to benefit from the proposed policy and how?

The programme aims to benefit children, young people and families who are currently facing barriers that prevent them from getting involved in the arts, primarily as audience members.

The programme will put in place creative interventions that remove barriers and encourage involvement.

3. How has the policy been, or will be put into practice, and who is or will be responsible for delivering it?

We are making funding available to venues and arts organisations to work collaboratively and develop innovative ideas that will help remove barriers and encourage involvement. We are inviting proposals and will decide which of these offers the most effective means of increasing engagement, but also offers the most innovative and creative approach.

The arts organisations will be responsible for the delivery. We will be responsible for funding and monitoring.

Children, young people and families living in areas of high deprivation are a high priority for this programme. Links to our child poverty plan are also a priority. This includes disabled young people and their families and young people from Black and Minority ethnic backgrounds. Opportunities for young people from Welsh language backgrounds are also a priority.
